Important Information to all students:

A) Who May Apply

- Secondary 4 Normal (Academic) student who is applying for/enrolled in the NAFA Foundation Programme.
- Singapore Citizen who is eligible for subsidies for the NAFA Foundation Programme; and
- ^Gross monthly household income (GHI) not exceeding \$2,750 or gross monthly household #Per-capita income (PCI) of \$690 and below.

Explanatory notes:

^Gross Household Income (GHI): Total gross monthly income of immediate family members, and non-immediate family members living in the same household.

#Per-capita Income (PCI): Gross household income divided by number of immediate family members, and non-immediate family members living in the same household.

B) Value of Bursary

Successful applicants who meet the criteria will receive the bursary valued at **\$970 per annum**. The bursary will first be used to defray the NAFA Foundation Programme's tuition fees and miscellaneous fees, before awarding the student with the balance for other education purposes.

C) Submission of Application

Complete and submit this application form, together with the following supporting documents by the closing date:

- Copies of all employed family members' latest payslips, Income Tax assessment or income certification letter by employer. For unemployed or self-employed family members, please fill up the attached "Income Declaration Form". [Please make additional copies if required]
- Copies of divorce / death certificates where a parent is no longer around, and/or court papers (if any).
- Other information about yourself that may support this application (if any).
