- NAFA offers Diploma programmes with a duration of 36 months, of which students are required to fulfil 120 credits required of their programme in order to graduate. However, under exceptional circumstances, students are allowed up to 5 years to complete the programme.
 - Upon the successful completion of a diploma, you may apply for our Degree programmes. Acceptance into these Degree programmes are not automatic and are subject to:
 - Entry requirements set for the selected programme
 - A Portfolio interview or Audition
 - **Admission requirements** include:
 - Potential in Artistic Talent and Creativity (Admission Test/ Audition/ Portfolio Submission)
 - English Language Proficiency
 - Educational Qualifications
 - Age Requirement

- The **Tuition Grant Scheme (TGS)** was introduced by the Government to help students with the cost of tertiary education in Singapore.
 - Eligible **Singapore Citizens** are automatically awarded a Tier A Tuition Grant, which is the highest level of tuition fee subsidy, Singapore Citizens thus pay the lowest tuition fees. There is no bond obligation.
 - Eligible **Singapore Permanent Residents (SPRs)** may choose to apply for a Tier B Tuition Grant only. Successful applicants are required to work for a Singapore entity for three years upon graduation.
 - Eligible **international students** may choose to apply for a Tier C Tuition Grant only. There is a limited number of Tuition Grants available for international students, and selection is competitive and based on merit. Successful applicants are required to work for a Singapore entity for three years upon graduation.
 - The Tuition Grant is not transferable between programmes. The applicant may be required to take another Admission Test, Audition or Portfolio Submission if he/she would like to apply for another programme.
 - Applicants who have exceeded the maximum TGS cap of 10 semesters or graduates from the local polytechnics (SP, NP, NYP, TP or RP), universities (NUS, NTU, SMU, SIT, SUSS and SUTD) or LASALLE College of the Arts, are no longer entitled to the Tuition Grant and will have to pay the full programme fees for their study at the Academy.
 - For Singapore Permanent Residents (SPRs) and international students, you will be contractually obliged to work in a Singapore entity for three (3) years upon graduation in exchange for the grant received under the Tuition Grant Scheme.
 - SPRs and international students who applied for the grant successfully are required to execute a Tuition Grant Agreement with the Government of Singapore, represented by the Ministry of Education (MOE). Students who do not sign the agreement will have to pay non-subsidised fees for their studies at NAFA.
 - SPRs and international students who fail to complete the programme (e.g. withdrawal or termination) or fulfil their bond obligation, will be required to pay liquidated damages. The amount of liquidated damages is computed based on the total Tuition Grant (inclusive of any GST subsidy) that you have received during the duration of study plus 10% compound interest per annum. The amount of liquidated damages will be reduced proportionately if you have served part of your Tuition Grant bond obligation.
 - SPRs and International Students who wish to defer their Tuition Grant bond obligation are required to apply through the MOE TGOnline portal (<https://go.gov.sg/tgwebsite>) at least 6 weeks before the commencement of your deferment period. The deferment application is subject to MOE's approval on a case-by-case basis and submission of a Banker's Guarantee. Failure to seek MOE's approval for deferment before you commence your further studies is a breach of the Tuition Grant Agreement and you may be liable to pay liquidated damages. Upon completion of your further studies, you may claim your Banker's Guarantee after you report to MOE with proof of employment to serve your bond.

FOR INTERNATIONAL STUDENT

- **Student's Pass (STP)**
 - The Immigration and Checkpoints Authority (ICA) is the primary authority that controls immigration matters.
 - Part-Time work of up to a maximum of 16 hours per week is permitted

 - Terms and Conditions are issued by the ICA for the STP
